Country Casual does NOT make cushions or pillows to custom sizes. All cushions are sized for an exact fit on Country Casual furniture. Use this form to order Country Casual cushions or pillows in a fabric from an outdoor fabric pattern book.

Additional fees apply and lead times vary. Price will be quoted upon return of this completed form. Fabric availability is not guaranteed.

Special orders must be paid-in-full at time of order, are non-refundable and cannot be returned or exchanged.

Special orders must ship to a valid street address. We cannot ship to a P.O. Box.

## SELECTING YOUR FABRIC

To ensure the professional quality and durability of your items, Country Casual recommends that you choose fabrics that are suited to your intended use.

If you will use the items outdoors, we recommend a fabric that is 100% solution-dyed acrylic to reduce fading and improve dry time.

Choose any 100% solution-dyed acrylic fabric from an outdoor fabric pattern book. All fabric is subject to Country Casual sewing approval.

Availability of fabrics is subject to change and will be confirmed before your order can be processed.

Upon confirmation of fabric availability and sewing approval, Country Casual will send you a swatch of the fabric for your review. Fabric must be approved by you before your order can proceed.

All fabric must be available on standard 54 in. wide roll of continuous yardage.

Country Casual cannot guarantee that stripes or patterns will be cut the same on all cushions or pillows.

On bench cushions over 50 inches in length, striped fabrics will run side-to-side instead of front-to-back\*.

\* If you want to specify the running direction for stripes or the placement of a repeating motif, yardage required for your order will increase. Contact us for a quote.


